We kindly request you to follow below guidelines in relation to Schedule Changes for confirmed un-ticketed segments • QR code-share flight numbers operated by WY aircraft, provided no WY operating flight number is booked on QR operating flights. published 5. Multiple airport cities may be considered as the same point, i.e. IST/SAW, LGW/LHR, HND/NRT Definition 6. In case of airport or origin/destination change, no compensation of reimbursement of surface transportation Schedule Change is a planned change or cancellation of a flight, which occurs more than one day prior to schedule and/or hotel accommodation will be provided by QR departure of the first impacted flight. 7. Passenger is responsible to follow any travel requirements and restrictions imposed by government authorities, incl. immigration regulations Notification to Customers and Processing Guidelines It is the responsibility of the Tour Operator Partner making the booking to notify the customer, acknowledge the **Fare Quotation Guidelines** schedule change and if necessary, reissue the ticket. 1. Ticket shall be issued at the Tour Operator fare and YQ, YR charges and Q surcharges which were applicable for confirmed space in RBD booked prior to schedule change Applicability 2. Tour Operator Fare Basis conditions which were applicable for confirmed space in RBD booked prior to schedule These guidelines apply only for Travel Agents who are authorized to issue QR (157) tickets on Tour Operator Fares change apply and should be distributed by Qatar Airways accordingly. 3. Taxes, fees, charges (other than YQ/YR charged by QR) and surcharges (other than Q charged by QR) shall be collected as applicable at the time of actual ticketing New date of travel for coupons impacted by Schedule Change 1. May rebook for a new travel date within (+/-) 3 days from original. In case of non-daily flight operation, you may **Ticketing Guidelines** 1. Tour Operator Fare Basis Code, Ticket Designator, Tour Code (Deal Code), Fare Calculation and Free Baggage rebook up to the earlier or next day of operation, but not more than 7 days from original 2. Due to severely affected travel plans by Schedule Change (e.g. reduction in the length of stay – less number of Allowance should be specified according to Tour Operator Fare Basis/Conditions applicable for confirmed space days at point of destination and/or stopover), passenger may rebook outbound and inbound to match original in RBD booked prior to schedule change length of stay. In case of non-daily flight operation, you may rebook up to the earlier or next day of operation, 2. The beginning of the Endorsements/Restrictions Field should reflect the characters "SKCHG TO COMM1082" but no more than 7 days from original followed by Tour Operator Fare Basis endorsement/restrictions applicable for confirmed space in RBD booked prior to schedule change, otherwise ADM will be raised Schedule Change Situations 3. Unless otherwise specified, tour operator partners are not authorized to endorse Tickets as "INVOL", 1. Change in the arrival or departure times beyond 2 hours or resulting in misconnection, change in class of service, "INVOLUNTARY", etc. frequency of operation, as well as flight cancellations 2. May apply these waivers also for connections, where original transit time at DOH did not exceed 8 hours, **Ticket Changes and Refunds** however, schedule change resulted in transit time beyond 8 hours 1. Voluntary changes and refunds are subject to ticketed Fare Basis, taxes, fees, charges and surcharges, as well as applicable penalties **Rebooking Options for QR Schedule Change** 2. Any subsequent schedule change is subject to COMM1068 Schedule Change Guidelines One of the following options may be selected by the customer: 1. Accept option offered by automated re-accommodation tool (i.e. UN1/TK1) Miscellaneous 2. Rebook on QR operating flight(s) from/to the same origin, destination in the same QR booking class as original, 1. No-show condition cannot be waived in case that passenger is reported as no-show or if not available, up to next two higher QR booking classes within the same cabin 2. Travel Trade Partners should update PNRs with passenger's contact information via SSR CTCE/CTCM/CTCR that passengers may obtain timely information in case of operational disruptions Notes for Rebooking 3. Please contact local QR office or QR Customer Contact Center in case of cabin class downgrades, Passenger Type 1. Please rebook the entire O&D to maintain Marriage Segment Control (MSC) Code (PTC) change, etc. 2. Free of charge upgrade to higher cabin must not occur 4. Commissions, Corporate Discounts, etc. should be applicable according to confirmed space in RBD booked prior 3.
